You are hereby notified that at 9 am on February 9th 2021, the Middle Township Board of Hendricks County, Indiana, pursuant to notice heretofore given under and virtue of IC 36-8-19-8.5 the Board will be considering the reestablishment of the Pittsboro Fire Protection Territory Equipment Replacement Fund, location of the meeting will be at 400 East Main Street, Suite B, Pittsboro, Indiana.

To the taxpayers of Town of Pittsboro Hendricks County, Indiana. You are hereby notified that at 7 pm on February 16th 2021, the Pittsboro Town Council of Hendricks County Indiana, pursuant to notice heretofore given under and virtue of IC 36-8-19-8.5 the Council will be considering the reestablishment of the Pittsboro Fire Protection Territory Equipment Replacement Fund, location of the meeting will be at 80 North Meridian Street, Pittsboro, Indiana. Due to COVID-19, the Town Council meeting will be held in a virtual setting so any comments from public will have to be done electronically.

The rate for the fund will be reestablished at .0333 per hundred dollars (\$100.00) of taxable real and personal property located within the units of Middle Township (provider unit) and the Town of Pittsboro (participating unit). The proposed reestablished fund will be levied beginning with taxes due and payable in the year 2022. This fund will be used for the replacement of equipment and buildings for the Pittsboro Fire Protection Territory

**ORDINANCE/RESOLUTION REESTABLISHING
FIRE PROTECTION TERRITORY EQUIPMENT REPLACEMENT FUND
IC 36-8-19-8.5**

BE IT RESOLVED by the Pittsboro Town Council, Pittsboro Indiana that a need now exists for the reestablishment of a Fire Protection Territory Equipment Replacement Fund for the following purposes:

BE IT FURTHER RESOLVED that this Board will adhere to the provisions of Indiana Code IC 36-8-19-8.5. The proposed fund will not exceed .033 on each \$100 of assessed valuation. Said tax rate will be levied beginning with taxes for 2021 payable 2022 and will be a uniform tax rate.

BE IT FURTHER RESOLVED that proofs of publication of the public hearing held on the 16th day of February 2021, and a certified copy of this ordinance/resolution shall be submitted to the Department of Local Government Finance of the State of Indiana as provided by law. This Fund is subject to the approval of the Department of Local Government Finance.

BE IT FURTHER RESOLVED that Middle Township is the Provider Unit of the Pittsboro Fire Protection Territory and Town of Pittsboro is/are the Participating Unit(s) of said Fire Protection Territory. Middle Township, as Provider Unit, is authorized to reestablish this Fund. This ordinance/resolution contains or incorporates by reference the contents of the agreement to establish the Fund.
